



## **2026 BOARD DIRECTOR NOMINATION FORM**

Dear Member,

In accordance with the Constitution of the Kytherian Association of Australia, an election for Director's positions is required to be held at the Annual General Meeting on Wednesday, 27 May 2026. This will be for the 2026 - 2028 period.

If you are interested in nominating for a position as a Board Director, you must be, and have been, a financial Full Member of the Kytherian Association of Australia for the last two (2) years. In addition, you must be over 18 years of age.

A Full Member is defined in the KAA Membership Policy as –

- a) Born or descended from persons born on the Greek island of Kythera, or
- b) married to, widowed from, adopted by, or in a de-facto relationship with any person born or descended from persons born on the Greek island of Kythera.

The proposer and seconder must also be current financial Full Members.

Prior to nominating, please read the Constitution of the Kytherian Association of Australia and the Conflicts of Interest policy both of which can be located on the Membership page of the Kytherian Association of Australia website – [kytherianassociation.com.au](http://kytherianassociation.com.au).

In addition, ensure you read and understand the Personal Board Director Declaration located on page 3 of this document.

Please provide a brief biography and include your reasons for nominating and what you would bring to the Board that can be published in the May edition of the Kytherian newsletter to help members make an informed voting decision.

The statement should be no longer than 150 words and be signed by you. It will be reprinted exactly as supplied so ensure it is accurate. Please also supply a photograph to be published together with your biography.

On applying, you will receive an acknowledgement from the Secretary that your nomination has been received.

An election will only be held if there are more nominations than available positions.
